**AN ORDINANCE TO RECLASSIFY CERTAIN ZONING  
AND CRIMINAL ORDINANCES.**

**THE VILLAGE OF PORT AUSTIN ORDAINS:**

**Section 1. Purpose.**

The reclassification of certain zoning and criminal ordinances, previously adopted, to civil infractions as specified in Ordinance No. 90-04 adopted on the 30<sup>th</sup> day of July, 2004 and published the 3<sup>rd</sup> day of August, 2004.

**Section 4. Adoption.**
